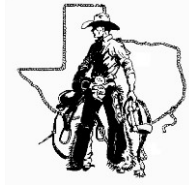

Nomination for Annual Texas Rodeo Cowboy Hall of Fame Induction Must be received by August 31st of current year

WHO CAN NOMINATE?

- You must be a current Sustaining or Associate Member of the Texas Rodeo Cowboy Hall of Fame to submit a nomination.
- **Incomplete or inaccurate bios will not be considered:**

NOMINEE ELIGIBILITY

- AGE: Nominee must be at least 35 years old. Special circumstances such as death or retirement may be considered.
- TEXAS RESIDENT: Nominee must have been raised in Texas or have been a Texas resident for five (5) years during the time of rodeo activity and have listed Texas as their home state. *It is the responsibility of the Individual nominating to verify the Texas Eligibility clause* either by ProRodeo Sports News or other valid publications.

NOMINATION PROCESS

- STEP 1. Current Sustaining and Associate Members may submit nominations.
- STEP 2. The Board of Directors will determine the categories and number of individuals for induction in each category. Generally, the categories are as follows:

Men Contestants	Deceased
Women Contestants	Rodeo Organizations & Groups
Rodeo Personnel	Rodeo Animals
Gold Card (70 yrs +)	
- STEP 3. The Inductee 'Finalist Selection Committee' (FSC) composed of past Inductees will review the nominations.
- STEP 4. All current Sustaining and Associate Members vote on who is to be inducted.
- STEP 5. The RODEO REUNION & TRCHF INDUCTION held each year in April.

NOMINATION PACKAGE – REQUIRED MATERIAL

1. The completed Nomination Form.
2. Photos: must include a minimum of two photos of the nominee suitable for reproduction, including 1 action and 1 head shot (submitted in form of a .jpg or pdf file). TRCHOF may request more photos later for our Induction Luncheon video we create.
3. A Biography; approximately 75-200 words or less. best submitted as a Word Doc via email but must be typed and mailed. This will be used on the plaque and ready for production. No changes after February 1st of the respective year.

NOTE: Incomplete or inaccurate biography application packages will not be considered.

RODEO BIOGRAPHY.

Nomination must include a short-typed biography (approximately 75-100 words or less) The biography should include the following examples of accomplishment in bullet point form. Incomplete or inaccurate bios will not be considered. The biography should include the following accomplishments:

- Early rodeo career such as qualified Texas High School Finals, College National Finals & year(s).
- Rodeo events
- Rodeo associations such as PRCA, CRA, UPRA, IRA, etc.
- Rodeo title(s) & year(s) such as qualified for National Finals Rodeo, CRA, UPRA, etc.
- Association final(s) & year(s) such as PRCA World Championship, etc.
- Major rodeos won & year(s) such as Cheyenne, Salinas, etc.
- Other rodeo achievements
- Preferred nomination category (subject to Finalist Selection Committee approval)

PHOTO REQUIREMENT:

Nomination must include a minimum of two photos of the nominee including 1 action and 1 head shot suitable for reproduction. Photos are best submitted as pdf or jpeg files but may be mailed. They should be 8"x10" landscape orientation (i.e. 10" across top). Please note that Xerox copies and newspaper clippings do not work. Also, permission from owner to use or post photos.
